1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe, and if they are posted, rules and warnings, and further agree to follow any oral instructions or directions given by The Trinity Church of Manson, or the employees, representatives or agents of The Trinity Church of Manson to include the power to make appropriate decisions regarding clothing, bodily nourishment, and shelter.

2. ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above-described activity and I assume full responsibility for personal injury to myself and, if applicable, to my family members, and further release and discharge The Trinity Church of Manson for injury, loss or damage arising out of my or my family's use or presence upon the facilities of The Trinity Church of Manson, whether caused by the fault of myself, my family, The Trinity Church of Manson or other third parties.

3. INDEMINIFICATION. I agree to indemnify and defend The Trinity Church of Manson against all claims, damages, judgements, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of The Trinity Church of Manson.

4. FEES. I agree to pay for all damages to the facilities of the The Trinity Church of Manson caused by my negligent, reckless, or willful actions by me or my family.

6. MEDICAL AUTHORIZATION. In the event of injury to the above listed minors during the above-described activities, I give my permission to The Trinity Church of Manson employees, representatives, or agents to arrange for all the necessary medical treatment for which I will be

financially responsible. This temporary authority will begin on June 23, 2025 and will remain in effect until terminated in writing or June 27, 2025, whichever occurs first. If The Trinity Church of Manson cannot contact me at number(s) below, they shall have the following powers:

- a. The power to seek appropriate emergency medical treatment or attention on the behalf of my child as may be required by the circumstances, including without limitation, that of a licensed medical physician and/or hospital.
- b. The power to authorize medical treatment or medical procedures in an emergency situation as directed by a medical provider.

7. APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above shall be resolved under North Carolina Law.

8. NO DURESS. I agree and acknowledge that I am under no pressure or duress to sign this agreement and that I have been given a reason opportunity to review before signing. I further agree and acknowledge that I am free to have my own legal counsel review this agreement if I so desire. I further agree and acknowledge that The Trinity Church of Manson has offered to refund any fees I have paid to use the facilities if I choose not to sign this agreement.

9. ARMS LENGTH AGREEMENT. This agreement and each of its terms are the product of an arm's length negotiation between the parties. In the event any ambiguity is found to exist in the interpretation of this agreement, or any of its provisions, the parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

10. ENFORCIBILITY. The invalidity or unenforceability of any provision of this agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any provision of this agreement or of any other applications and provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be part of the agreement.
